Consultation and Trial:

We require every bride to do a trial run before the wedding day.

Bring all hair related accessories that you will wear at your event, such as your veil, hair/head jewelry, etc. The consultation/trial will take about 2 hours.

Please note, on the day of your event, we will recreate the look we achieved and or determined during your trial.

PRICES:

Bridal Hair Trial: \$75.00

(includes a trial for each event booked for—ie Ceremony, Reception etc)

Bridal Day-of Event Style: \$200.00/look/day

(includes pinning, hair extensions, hair jewelry, touchups)

Bridal Party Style: \$80.00/look/day

Mothers, Mother-in-laws/Aunties: \$80.00/look/day

Gratuity is not included but always greatly appreciated.

All services are priced at per service rate and include the use of professional hair products and supplies. The rate does not include the cost of travel/toll and parking, headpieces, hair extensions, hair accessories, and flowers etc. These items/costs will be negotiated separately. The client is responsible for all additional parking/toll fees that may be incurred for each day/event.

Important information for your Bridal Hair Service

To help us serve you better and ensure that your wedding day runs smoothly, we ask that you and your wedding please follow these simple guidelines:

- Please arrive with clean, dry hair to help the hold of your hairstyle. Only use styling aids recommended and determined at your trial. An additional fee may apply if you request a wash and blow dry or straightening other than was previously discussed.
- On the day of your event, please wear a buttoned up shirt or robe so you don't damage your style when changing into your gown or bridesmaid dress.
- Most importantly, please be on time for your wedding day appointment. Even starting 15 minutes late will put everyone behind and we don't want you to be late for your special day!

I, _____, agree to the scheduled appointment times/dates and the price listed above. I understand and agree to the deposit of 30% of the total package price at the time of scheduling. I agree to pay the balance due by the last day of the event(s) by cash or check made payable to Jeffrey Stiglich. I understand that the deposit will not be refunded upon cancellation. If cancellations are made with less than 72 hours' notice, the entire cost of the adjusted or cancelled services will be my responsibility to pay. I understand that no refund will be given for members of the wedding party who miss their appointment on the day of the event. If the artist cannot perform the agreed upon services due to unforeseen circumstances beyond control, on the event day, 100% of all payments shall be returned to the client with the understanding that there will be no further liability with respect to the agreement. This Agreement shall be binding upon the parties, their heirs, successors, assigns, and personal representatives. This Agreement constitutes the entire understanding of the parties.
